Rules and requirements

- Complete and track 120 gym workouts within 12 months from the start date you indicate on the first page. A gym staff member must sign each entry.
- Use one log per member. Print copies for eligible family members.
- If your gym can provide a printout of your visits, you can use the printout and have a gym staff member sign it in lieu of using this log. We recommend you keep a copy of the log for your records.
- Send Horizon BCBS all of the following:
 - Your completed log or the signed printout from your gym
 - Your receipt of your annual gym membership fee
 - A Horizon BCBS medical claim form

Restrictions

- Reimbursements are made to eligible members. Dependent children must be 18 years of age or older to receive reimbursement.
- The total reimbursement for a family cannot exceed the total cost of the family fitness club annual membership fee.
- Competitive or recreational programs do not qualify for reimbursement.
